



Advice Line One Time Purchase Terms and Conditions

Description of Service

1. The Osola Advice Line Service is a general health and safety advice service, it is not a full consultancy service.
2. The advice will be provided by a named competent advisor who will be either an employee of Osola or one of our named associate advisors. If we believe we are not competent or best suited to advise you on a particular subject, we will advise you of that and direct you to a more suitable source of advice.
3. The advice we provide is based on the current health and safety legislation of Great Britain. While we can advise on the general principles of health and safety and risk control, we cannot advise on the legal requirements of other countries or legal compliance within different legal systems.
4. The advice we provide will be based on the information you provide to Osola Ltd and our associates advisors. We cannot be held liable if you omit relevant information or provide incorrect information to Osola Ltd and our associate advisors. We will of course endeavour to establish and clarify with you all relevant information prior to providing our advice.
5. Our advice will be based on our interpretation of the relevant health and safety law, published guidance and good industry practice. We will endeavour to support our considered opinion with reference to those laws, published guidance, and industry practice. However, enforcing authorities and the Law Courts may interpret the application of the law differently in reference to a given set of circumstances and we cannot be held liable for any losses that may occur in this circumstance.

Access to the service

6. Access to the Advice Line Service is restricted to the individual or organisation in whose name the purchase was made. It cannot be transferred to, or used by, another individual or organisation.

Fair use Policy

7. A one-time purchase affords you one hour of advisor time over a 30 day period, referred to as the purchase period. This time can be used in units of 15 minutes up to the full 60 minutes. A relatively straightforward enquiry would use 15 minutes, a more complex enquiry will take longer.

Allocation of time

8. The allocation of time spent on an enquiry will include.
 - (a) initial communication with you the client, (whether by telephone, email, or other online communication platform), to establish the nature of the enquiry.
 - (b) any subsequent communication with you for clarification or confirmation of relevant information,
 - (c) any necessary research time required to establish the most appropriate advice and,
 - (d) final communication with you to provide that advice in your preferred format.
9. Our aim at Osola is to build rewarding and enduring relationships with our clients, we want to get to know you and you, us. To that end there will inevitably be time spent on general chit chat, this time will not be taken from your subscription time.

Likewise, we will not nit-pick over an extra few minutes here or there spent on your enquiry. If, however your enquiry requires more time you will be able to buy additional time at your original purchase rate.

Payment & Cancellation

10. Payment must be made in full at the time of purchase. You have 14 days to cancel your purchase and obtain a refund. After the 14 day cooling off period you can cancel your purchase, but your payment cannot be refunded.
11. If you require to use the Advice Line service within the 14 day cooling off period, and then decide to cancel you will be refunded the full price minus the cost of the time used.
12. Any time remaining at the end of the 30 days is non-refundable and cannot be carried over into a new subscription or purchase period unless the new subscription or purchase is made within the initial 30 day period.

Accessing the Advice Line Service

13. To access the Advice Line Service, you will be provided with contact details and can initiate an enquiry in the first instance by email. Once we have received your enquiry, we will either respond directly with our advice or contact you for further information or discussion. We may ask you to provide photos, video, documentation, or other information in order for us to get a full picture of the issue.
14. We aim to respond to all enquiries within 4 hours during normal business hours, there may however be occasions where this is not possible due to circumstances beyond our control.

Discounts for Subscribers

15. For the duration of your 30 day purchase period, you can purchase any Osola online training course at a 10 % discount This discount rate cannot be used in conjunction with any other discounted offer.

Open Office Hours

16. We hold regular open office sessions. This in an informal web chat where we discuss a current hot topic, a new development, share experience and answer more of your general questions for the benefit of all in attendance.
17. Your one time purchase gives you free access to any open office sessions we hold within your purchase period. When a session is scheduled you will be notified by email giving you the joining instructions and the opportunity to ask some questions in advance.
